In the event a breach cannot be completely cured within the 30 days allowed to cure the breach, and curing process has been started within 30 days, and the breaching party has been diligent in its efforts to use through the period, both parties may agree to continue the agreement until such time as the breach is cured. Rightful termination hereunder shall be without prejudice to any other rights or remedies a party may have.

This agreement shall be governed and construed within accordance with the laws of Washington State. This agreement constitutes the entire agreement between the parties and may not be modified, amended or changed except by a writing signed by all parties to this agreement.

This agreement shall be binding upon and inure to the benefit of the parties hereto and their respective successors and assigns, provided that neither party hereto shall have the right to assign this agreement or delegate any duty, service or responsibility hereunder without the prior written consent of the other party. Each party to this sponsorship agreement warrants and represents that the individual signing this agreement on behalf of a corporate party has the authority to bind his or her respective company in and to the terms of the agreement and each party further warrants and represents that is authorized to enter into this sponsorship agreement.
